**ODE EMIS Focused Training** – ODE EMIS "Career Tech" focused training sessions will be held this week on Tuesday 9/20 and Thursday 9/22. Please see the ODE EMIS webpage for more information (EMIS > Resources > EMIS Focused Training).

**FY23 Collections opening** – Three collections are scheduled to open this Thursday 9/22: FY23A Summer & Fall EOC (summer results should be back by now so they can be submitted), FY23A KRA, and FY23S Current Grad-Credit Progress.

**FY23S SOES Enrollment Collection** – ODE sent an email to ITCs this morning regarding 33 Community Schools that have not submitted the Initial SOES Enrollment (AODE) collection yet. Community School October payments will be based on LIVE FY23 data, so if they haven't submitted SOES enrollment data yet they may not get a payment next month. This data pull will be Friday 9/30, based on data submitted before 5pm on Thursday 9/29. Please do not wait that long to do so and risk your community school not getting a payment.

**<u>FY23 ODDEX Tuition</u>** – Fall review window is currently open for any Traditional districts with tuition situations.

**FY22H Financial Data Appeals** – The deadline to request an appeal is this Friday, 9/23. If an LEA did not submit this collection at all (and there are a few), they *must* request an appeal. An appeal *may* be requested if an LEA has issues and would like to resubmit their data. Once a request is approved, the deadline to submit corrected data is 5pm October 14. There are some entities that have not submitted this collection and have still not requested an appeal either. ODE is reaching out to make sure they request an appeal so they can get their data submitted.

**FY22A Preschool Early Learning Assessment Appeals** – Data appeal window opens next Monday, 9/26 with the deadline to request an appeal by October 7. Once a request is approved, the deadline to submit corrected data is 5pm October 13.

OEDSA Conference – ODE's EMIS presentation will be Friday 9/30.

## <u>Q&A</u>

**Q:** If a Community School's SOES Enrollment collection was submitted but they haven't submitted their SOES Contact collection, does that impact funding?

A: Contact collection doesn't impact funding anymore, but they should still get it in.

Q: Do you have any news for FY23 PEBT?

**A:** No, that info will come from ODE's Child Nutrition Office, and we believe they're waiting on further information from USDA on the rules. ODE EMIS is not involved in that process.

Q: How often is the CTE follow-up report being updated, and why would this year's seniors be on there?
A: ODE is updating that report weekly during the CTE Concentrator Status appeal window. You should see updated reports this morning in the Data Collector. Current year seniors would appear on this report if they have met CTE Concentrator status but have not been reported to ODE in Initial "S" (1TRD

or AODE) as enrolled this year. They don't need to file an appeal in this situation because as soon as they report their FY23 enrollment, currently enrolled students should drop off when the report is refreshed. If that is not happening (they have submitted enrollment information and see the students on the FTE report, but they are still appearing on the CTE follow-up report) put in a helpdesk ticket. If they reported enrollment last week, the students should be off today's updated report.

**Q:** The file contains students with WD codes 40, 43, 46 and 52. We opened a ticket and ODE said they have not been filtered out yet.

A: Those codes should be filtered out of today's report.
