### DISCIPLINE TABLES REQUIRING MANUAL UPDATES FOR CIVIL RIGHTS REPORTING

- Currently districts are seeing the following labels in their downloadable report for 23/24 CRDC, and these four areas are not calculating the data properly for the fields. It will need to be manually calculated and added to the .csv file that is submitted to CRDC (or entered directly into CRDC if that is how your district is reporting)
  - DISC-14a: Students without disabilities who received Expulsions with Educational Services (as currently displayed in the CRDC Report download) will be DISC-13a: Students without disabilities who received Expulsions with Educational Services, after v.24.2
  - DISC-15a: Students with disabilities who received Expulsions with Educational Services (as currently displayed in the CRDC Report download) will be DISC-14a: Students with disabilities who received Expulsions with Educational Services, after v.24.2



### DISCIPLINE TABLES REQUIRING MANUAL UPDATES FOR CIVIL RIGHTS REPORTING, CONT.

- These four tables are not calculating the data correctly due to changes in how expulsions and services are handled in StudentInformation
- Story PBSIS-36459 CRR Update logic for Discipline tables Expulsions, has been submitted and is tentatively scheduled for v.24.2
- Prior to v.24.2 being released, to get the correct values for these 4 areas, they will need to be manually calculated; if included in v.24.2, the values may calculate correctly as this is a tentative update



### DISCIPLINE TABLES REQUIRING MANUAL UPDATES FOR CIVIL RIGHTS REPORTING, CONT.

- Districts will need to manually calculate the values for each of the 4 tables on the previous 2 slides, and then populate the specific columns in the Civil Rights Report .csv file (or enter the data on the CRDC website) after they have calculated the correct values
- These four slides show the data from the current display in the report from StudentInformation

### MANUAL UPDATES TO .CSV CRDC FILE

- The next four slides contain the headers for each of the values that need to be manually calculated for the referenced discipline table, and once calculated, these are the areas where the data will be placed in the .csv file to report
- If districts are submitting their CRR data prior to the release of v.24.2, they can enter the values required for fields not yet in the .csv file in StudentInformation at the CRDC using the column headers contained in the following document:
