## Enhancements

## Home Screen

• On the **DataMap > Students** screen, if your search results include indicators in the **Gifted** column and then you click (Export icon) to export the list of matching students, there is now a column for each gifted area and specific ability area. If the student is gifted for an area, "Y" is displayed in the associated column; otherwise, the column is blank.

## Import Assessment Scores

 (PBSIS-35434) For the DIBELS 8 Import, formats have been updated for 2023/2024 and 2024/2025 school years and beyond. The Composite Score will display on the Multiple Measures screen and on the Student Roadmap in the Data Points History section under "English." All other DIBELS 8 data points will display under "Reading."

## RIMPs

- When you click the Assessment field in the following locations, assessments in the drop-down selection list are now grouped under the headings Additional Assessments or Approved Assessments. If an assessment is on the Ohio Department of Education and Workforce (ODEW) list of approved assessments, it is listed under Approved Assessments. Assessments that have not been approved by ODEW are listed under Additional Assessments. This enables you to add scores to a RIMP for an assessment that is in addition to ODEW-approved assessments.

- o Add Progress Monitoring Measure window
- You can now delete an active RIMP for a student who has a **Reading Component** with added tutors without having to first delete any tutors on the **Reading Component** tab.

#### Absence Types

## **Report Card Publisher**

• The **Report Card Publisher** service has been updated to create a more complex file name so that there is no longer risk of the wrong report card getting tied to a student in the Vault.

### Nightly Integration

• (PBSIS-34456) Previously, the nightly integration stored procedure that creates new District Staff records could grant a staff member access to an archived database instead of the live production database. Now, an additional check has been added to the nightly integration stored procedure to ensure the process grants staff members access to the production database.

#### Progress Reports

 (PBSIS-35144) Previously, when a user was interacting with radio buttons on the Student Progress Report and the Student Progress Report by Assessments report, the user's selections were not recognized. Now, the radio buttons have been updated to reflect the user's selections.

## Report Cards

• Previously, when a student was registered, duplicate ProgressBook IDs could be created for different students. This was mainly an issue at non-public schools where it created issues when saving report cards to the Vault. Now, the ProgressBookId is a unique student ID.

• Previously, after the introduction of side navigation, some buttons below **Sign Out** on Google Classroom screens slightly overlapped **Sign Out**. Now, the spacing between **Sign Out** and buttons below it has been corrected.

## Enhancements

### **Student Profile**

• On the **Student Profile** screen, **Special Education** tab, you can now sort the documents listed in the **Completed Document** section by columns. By default, the list is sorted by the **Event Date** column, but you can click a column heading to sort the list by that column.

## Documents

#### **Student Documents**

- (PBSPS-4885) When you are working on a section of a document and click the link for the document title in the upper left corner to navigate to the **Document Overview** screen, if the system has not yet automatically saved the field values on the screen, the screen is saved and the "All Changes Saved" pop-up notification displays in the right corner of the screen before you are returned to the **Document Overview** screen.
- On the Student Documents screen, Documents tab, if you have selected to filter the tab by the Event Date range, you must now use the Calendar icon (<sup>1</sup>) to select Begin and End date to ensure the dates are in the proper format. You cannot enter these dates manually.
- On the **Student Documents** screen, **Banks** tab, you can now hover your cursor over the **Location** column to display a tooltip with the complete text for the location. Additionally, when text in the **Preview** column is cut off, an ellipsis (...) is now displayed to indicate there is more text. To view the complete **Preview** information, you can click the hyperlink in the **Name** column and scroll to the bottom of the **Banks** tab.



### Child Outcome Summary Form

- The Child Outcome Summary Form has been added as a new document available for selection.
  - When you click New Document, the Create New Document window now includes "Child Outcome Summary Form" as a selection in the Document field. When "Child Outcome Summary Form" is selected, the Type field and the Copy From field are not displayed in the Create New Document window.
  - Click **Create** on the **Create New Document** window to display the **Child Outcome Summary Form Overview** screen with the following sections:
    - 1. Entry Summary
    - 2. Annual Progress Summary
    - 3. Exit Summary

#### Attachments

When you are working in a section, you can click the left arrow to display the Quick Document Menu. You can click **Print Preview** or **Mark as Complete** in each section.

- The **Child Outcome Summary Form Overview** screen displays the status of each section ("Edit" or "Completed"), as well as the overall completed percentage for the COSF document.
- User bank items can be created for and inserted into fields for each section of the COSF document.

- Previously, when a **District Bank** item was selected for editing, the **Delete** button displayed even if the resource permission to delete an item from the **District Bank** was set to disabled. Now, the **Delete** button no longer is displayed when a **District Bank** item is selected for editing if deleting is not allowed.
- When creating a **Progress Report** from an open or completed **WEP**, users cannot select any type, except **WEP PR**. If a user selects another type and attempts to copy from an existing **WEP**, the following message displays: "You are unable to create a OP6A or OP6B or Transition for WEP."

## StudentInformation

#### Account Maintenance

• When a **Person** is created in **Frontline Administration**, StudentInformation no longer checks for duplicate email addresses during the account creation/edit process. For districts that have migrated to **Frontline Passport/SSO**, administrators can create a person in the **Frontline Administration** application using an email address that is already in use.

#### CORE Overflow

- On the **CORE Overflow** screen, the following **CORE Subject Areas** have been added for which you can manage a CORE required value and a subject area overflow:
  - DRI SCE
  - **ENE SOE**
  - MTE





## Course History

• (PBSIS-36243) A database change has been made to "tblCourseSectionPeriod" and "tblCourseSectionStudent" that will improve the runtime of VendorLink calls that access Student Course History data.

## EZ Query > Reports > SIS Student Search

• (PBSIS-35772) In the SIS Student Search report output, the heading of the Home Language column has been updated to Language Other Than English.

### **Graduation Points**

- On the **Grad Points Summary** screen, if a student has credit in a course with any of the following **EMIS Subject Area for Credit** codes, the credits are now displayed in the **Elective Credits** section and not the section for a subject area, and the credit is calculated as Elective credit:
  - "ENE English when counting as elective credit for state graduation requirements, not as part of 4 English Language Arts credits."
  - "MTE Math when counting as elective credit for state graduation requirements, not as part of 4 Math credits."
  - "SCE Science when counting as elective credit for state graduation requirements, not as part of 3 Science credits."
  - "SOE Social studies when counting as elective credit for state graduation requirements, not as part of 3 Social Studies credits."
- (PBSIS-32294) On the Grad Points Summary screen, if a student has credit in a Driver's Ed course with the EMIS Subject Area for Credit code of "DRI Driver' Ed as ELE credit for state grad reqs/not for Ind Cred CR 63," the credit displays in the Elective Credits section and is calculated as Elective credit. However, if the student has earned a CTE Industry Credential for the Assessment Type of "CR63 Ohio Driver's License" and also has a course with the EMIS Subject Area for Credit code of "DRI Driver' Ed as ELE credit for state grad reqs/not for Ind Cred CR 63," the course is not displayed in the Elective Credits section and is not calculated as Elective credit.
- On the Grad Points Summary screen, in the Show Competency in Algebra I and English II section under Additional Options, the following now show competency as Met in 3. Complete College Coursework if the student has any of the following program codes assigned:
  - English shows competency as Met ("English" is green and has checkmark) when program code "520101 – Alt Competency CCP Met English CCP Only" or "520100 – Alternative Competency CCP Math & English" is reported.
  - Math shows competency as Met ("Math" is green and has checkmark) when program code
     "520102 Alt Competency CCP Met Math CCP Only" or "520100 Alternative
     Competency CCP Math & English" is reported.



- On the **Student Exemptions/Requirements** screen in the **State System of Diploma Seals** section, the **Description** column has been removed from the grid. Above the grid, a link has been added to the Ohio Department of Education & Workforce website where you can view descriptions for diploma seals. Additionally, the name of the **Military Enlistment Seal (Ohio)** seal has been updated to **Military Seal (Ohio)**.
- On the **Student Exemptions / Requirements** screen in the **Graduation Plan Details** section, "Agriculture, Food and Natural Resources" is now an available selection in the **Career Field Interests** field. If "Agriculture, Food and Natural Resources" is selected, it is included in the output for the **Ohio Graduation Plan** report.

#### Import/Export

• The **Home School Import**, **Student Import** process has been refactored for improved performance and should now run faster.

#### School Building Administration > Calendar Wizard

- On the **Calendar Wizard** screen, the **EMIS Term** field has been added to the tabs below to enable you to copy the EMIS Term value from one year to the next when you are creating the Master Calendar for a building.
  - On the Reporting Terms tab, when you select a Report Card Frequency, the EMIS Term field displays on the tab. The selection in the EMIS Term field defaults to the default EMIS Term code for the selected Report Card Frequency.
  - On the Virtual Terms tab, the EMIS Term column has been added and is populated for each term listed from the value saved on the Reporting Terms tab. These values in the EMIS Terms column cannot be changed. When Virtual Terms are copied from a previous year, the values in the EMIS Term column default to the values reported in the year from which the Virtual Terms were copied. The values in the EMIS Terms column for Virtual Terms can be changed.

#### School Building Administration > School Demographics

• The **School Type** field can no longer be modified. The field is now display-only and unavailable for selection to prevent users from making changes to this field.

#### School Year Initialization

• The School Year Initialization process now populates EMIS Term values from the Calendar Wizard screen to the Initialization > Reporting Terms Maintenance screen. For districts that ran the School Year Initialization process prior to the installation of StudentInformation 24.2.0, a script will run that will copy any previous saved EMIS Term values from FY25 to FY26.

## Security

• On the View Staff Members screen or the View Accounts screen, search fields now display matching results if a user accidentally types or pastes an extra leading or trailing space into the field.

## Transcript Formatter (R702)

- (PBSIS-35457) If no years are selected in the **School Year(s)** for Marks field on the **Search Criteria** tab, report output now only includes data from the last 10 years from the selected school year in context.
- In the output for the **Transcript Formatter (R702)** report, the image displayed for the **Military Enlistment Seal** has been updated to reflect the name change to **Military Seal** for students who have earned this seal.

## Analytics Hub

- In the Assessments > Non-State Pre-ID folder, the SAT Pre-ID File report has been updated for the latest version of the file layout.
- In the **Eligibility** folder, the following updates have been added to the **Ohio Graduation Plan** report:
  - (PBSIS-33755) The name of the WebXams section has been updated to WebXam (OCTCA), and if the student has completed this requirement, "Completed" displays on the report. The row with the Test Date, CTE Assessment Code, and CTE Technical Score columns has been removed.
  - In the **State Defined Diploma Seals** section, the name of the **Military Enlistment Seal** has been updated to **Military Seal**.

Note: The Ohio Graduation Plan can also be generated from the Grad Points Summary screen.



## StateReporting

#### Assessments

- On the **OELPA** screen, when "ALT Alternate Assessment" is selected in the **Required Test Type** field, the following areas are now displayed for recording Alt-OELPA scores:
  - Receptive (Alt-OELPA Only)
  - Productive (Alt-OELPA Only)

In each area, you can record the following information:

- Accommodations: When "ALT Alternate Assessment" is selected as the Required Test Type, the Accommodations field defaults to "NO - Student did not receive accommodations on the STR test or took ALT" and cannot be changed.
- Score Not Reported
- o **Score**
- Standard Error (optional)
- Performance Level (Optional)

When Alt-OELPA scores are added for a student, either manually or by import, they are listed on the **Ohio English Language Proficiency Assessment (OELPA)** screen.

- On the **Assessment Import** screen, the import process has been updated to accept the FY25 import layout for the OELPA import and the ALT-OELPA Import.
- (PBSIS-36593) To prevent errors on the Assessment Import screen, the OST Import process has been updated to ignore "DOPR" contained in Positions 363 through 393 for High School End of Course (EOC) assessments that are administered in the Dropout Prevention and Recovery (DOPR) windows.

#### Assessment Reporting Collection (A)

• When "Transfer Assessment Data" is selected as the **Request Type**, and **Transfer – OELPA (GF)** is selected on the **Program Selection** tab, the transfer file includes the OELPA records for the current school year.

## DataMap EMIS Import

• On the **DataMap EMIS Import** screen, the option "On Track Statuses" has been removed from the **Please select an import** ... drop-down list since the Ohio Department of Education and Workforce (ODEW) no longer requires a TGRG Reading Diagnostic Status.

## EMIS Follow-Up Import

- (PBSIS-36468) After the initial file is imported using the EMIS Follow-Up Import screen, if you receive a second file from ODEW that needs to be loaded, columns A through O update with any new data for a student, while columns P through AO will not update with any new data for a student who has already been imported. The following columns have been added to the fields that will update with any new data:
  - I CTE INCLD FLAG
  - o J GRAD INCLD FLAG
  - K SWD INCLD FLAG

### Student Reporting Collection (S)

- The **Update Count of Graduation Credits at Entry** process has been updated to include credits from the **Student Course History** screen. The process will look at all the credits but use only the credits that are coded as high school credit. Districts will need to rerun the Count of Graduation Credits at Entry process once 24.2.0 is applied. This process is no longer dependent on the Non-Grad and Grad CORE Summary being run.
- The **Update Count of Graduation Credits at Entry** process now calculates correctly for students who were enrolled at a district, then withdrew and enrolled at another district where they earned credit, and then later re-enrolled at the original district. Per ODEW, when a student is not new to the district for the current year, when they come back, the value originally reported would remain the same for that school year, even if there was a period where they went to another district and came back.

  - 2d : Did this school have any preschool children who were already identified as disabled and eligible for services under Section 504 when they enrolled in the preschool?

## StudentInformation

## Edit Student Profile

• (PBSIS-36490) Previously, on the **Edit Student Profile s**creen, **FN-Attributes** tab, the **Count of Graduation Credits at Entry** field did not include credits for previous years that had been entered on the **Manually Entered Course** screen for a previously enrolled student who withdrew and was re-enrolled. Now, manually entered course credit displays correctly on the **FN-Attributes** tab, regardless of when the student re-enrolled during the school year.

#### **Course Maintenance**

(PBSIS-35137) Previously, the Add Course Section button on the Course Sections screen and the Add Course Group button on the Course Groups screen were still accessible for users in a role for which on the Security > Display Role Access screen, the sitemap security access for "Course Maintenance" was set to Display ( ) with the Add, Change, and Delete options set to not allowed (×). Now, when a user's role is display-only for "Course Maintenance" in the sitemap, the Add Course Section button is not accessible on the Course Sections screen and the Add Course Group button is not accessible on the Course Groups screen.



## EZ Query > EZ Students > Shared Student Data

(PBSIS-35676) Previously, if a student did not have a Primary Contact record for the school selected in the Choose trusted district and school field, no Primary Contact data displayed if "Addresses and Primary Contact" was selected in the Choose data to review field and "Primary Contact" was selected in the Address or Primary Contact field. Now, if the student does not have a Primary Contact record at the selected school, the Primary Contact from the student's home school displays. If the student has a Primary Contact record at both schools, information from both schools displays.

#### EZ Query > Tools > Absence List

• (PBSIS-2220) Previously, if a student had a time in value between 12:00 PM and 1:00 PM, the **In** column incorrectly displayed the time with the abbreviation "AM" instead of "PM." Now, time in values between 12:00 PM and 1:00 PM correctly display "PM."

#### Fees

• Previously, the **Students Needing Adjustment** screen timed out before loading the list of students. Now, this screen loads and displays correctly.

#### **Graduation Points**

 (PBSIS-31856) Previously, on the Grad Points Summary screen, under Additional Options in the Show Competency in Algebra I and English II section, if a student had met the EOC requirement for one subject (Algebra I or English II), the Show Competency area displayed "Completed." Now, the Show Competency area displayed "Completed" only if the student has met the EOC requirements for both Algebra I and English II.

#### Import/Export

• (PBSIS-36268) Previously, on the **Home School Import** screen, **Students** tab, an "Invalid Date" error was generated for any student in the import file with a Birthdate after 12/31/2019. Now, the Home School Import correctly imports students born after the year "2019."

#### **Registration Wizard**

• Previously, when a student was registered, duplicate ProgressBook IDs could be created for different students. This was mainly an issue at non-public schools where it created issues when saving report cards to the vault. Now, the ProgressBookId is a unique student ID.

#### **Student Promotion**

 (PBSIS-34454) Previously, selections saved on the Edit Student Profile screen, General tab in the Gender Identity field and the Preferred Pronouns field did not copy to the next school year during the Student Promotion > Promotion and Student Promotion > Student Bulk Enrollment processes. Now, the Student Promotion > Promotion and Student Promotion > Student Bulk Enrollment processes correctly copy up these selections.



### Student Transfer

- (PBSIS-32716) Previously, the value saved for a student in the Summative Race field changed during the Student Transfer and Bulk Student Transfer processes for students with "Y-Yes, the student is Hispanic/Latino" selected in the Hispanic/Latino field or with multiple racial groups selected in the Racial Group(s) field. Now, the selections saved for a student on the Edit Profile, General tab transfer correctly during the Student Transfer and Bulk Student Transfer processes.
- (PBSIS-32991) Previously, for a student enrolled in a future year and then transferred for the future year using the Student Transfer and Pending Students > Bulk Enroll District Transfers processes, the Disability Condition saved for a student on the Edit Profile, FD-Attributes tab did not transfer. Now, a student's Disability Condition transfers correctly during the Student Transfer and Bulk Enroll District Transfers processes for a future school year.

   Detail report did not highlight in blue the date a threshold was crossed if it was within the last 7

- (PBSIS-35491) Previously, in the **Eligibility** folder, in output for the **Ohio Graduation Plan** report, a student's saved **Work-Based Learning** hours for **Entrepreneurship** incorrectly displayed the student's saved **Job Site Placement & Internship** hours. Now, in this scenario, you can select \*\* (Not Applicable student did not test or accommodations not reported) in the Accommodations field as appropriate.

## Calendar Reporting Collection (C) > Calendar Collection Transfer

(PBSIS-36289) Previously, if a sub-calendar had the Expected to be in attendance between the first and last day of school on every box selected for a Saturday or a Sunday and the Transfer Calendar Data Process was run, the Transfer Calendar Data Process incorrectly created the attributes of C\_YWKDAYSA for a Saturday and C\_YWKDAYSU for a Sunday. Now, if the Expected to be in attendance between the first and last day of school on every box is selected for a Saturday or Sunday in a sub-calendar, the Transfer Calendar Data Process correctly creates the attributes of C\_YWKENDSA for a Saturday and C\_YWKENDSU for a Sunday.

#### **CTE Industry Credentials**

 (PBSIS-36261) Previously, on the CTE Industry Credential screen, the Assessment Area field did not include the selection "CR53 – NIMS: CNC Lathe Programming Setup & Operations." Now, this industry credential has been added for FY23 and forward, and if a student earns this credential, it is displayed on the Grad Points Summary, Industry Credentials screen, under "Manufacturing" with 6 points.

#### **District and Building Information**

(PBSIS-35204) Previously, in the Medical Group (Final Collection) section for School Year 2024-2025, no attributes were available for selection for the Glucagon, Epinephrine, Inhaler, or Diabetes Care Collections. Now, the attributes are available for selection for each Medical Group collection for School Year 2024-2025 and are included in the New School Year Script.

#### Staff/Course Reporting Collection (L)

- (PBSIS-21670) Previously, after a user ran the Verify/Update Course and Class List
   (CLISEMIS/CTRMEMIS) process with the Run Type of "Update (Delete all and create)," when the
   process completed, the Verify/Update Course Terms & Class List (L) screen incorrectly displayed
   the message "Update not run" for each building included in the run. Now, when the Verify/Update
   Course Terms & Class List process with the Run Type of "Update (Delete all and create)"
   completes, the message "Update Last Run on" correctly displays for each building in the run with
   the date/time and the name of the user who ran the process.
- Previously, when a user ran the Verify/Update Course and Class List (CLISEMIS/CTRMEMIS)
  process with the Run Type of "Update (Delete all and create)," there was an issue with the stored
  procedure "proc\_StaffCourseCollection\_Update" locking up the "dbo.tblStudentSubjectEMIS"
  table for long periods of time. Now, the stored procedure has been modified, so when users run
  Verify/Update Course and Class List (CLISEMIS/CTRMEMIS) in Update mode, the table will not
  lock up.

#### Student Reporting Collection (S)

- (PBSIS-28927) Previously, the Verify Student Special Education process displayed an error for students if on the Special Education screen, Events tab, a record had been saved with a Date Type of "CIEP IEP Consent Withdrawn by Parent" and an Extended School Year Services field selection of "\* Not Applicable." Now, the Verify Student Special Education process does not display an error for a student with these saved selections for a Special Education Event Type.
- (PBSIS-34726) Previously, the file created by the Transfer Exiting Student Follow-Up (FW) process contained duplicate student records if multiple people edited information on the Exiting Student Follow-up Records screen and saved at approximately the same time. Now, the Transfer Exiting Student Follow-Up (FW) file contains one record per student regardless of how many people are editing and saving the Exiting Student Follow-up Records screen.
