**FY25 Exiting Student Follow up Collection - Final** - ODEW is finishing the last checks for the Grads for the follow up file. Assuming everything is finished by today, April 28th, the Level 2 FLUP-001 files should be available tomorrow, April 29th. The fixed-length version, in the Received Files, should be updated later this week.

**EMIS Collection Requests** – The FY25 Midyear Student (2TRAD) Collection closed on Friday, April 25th. The FY25 End of Year Student (3TRAD) Collection and the FY25 Graduation Collection open on Thursday, May 1st.

**Data Collector Update** – Progress has been made on the installation of the new version of the Data Collector. There are 5 Data Collectors that still need to be updated with the new version. ODEW is asking for this to be completed by the end of this week.

Additionally, Alex Katz sent an email to the technical contacts at ITCs late last week regarding a hotfix. There is a regression in the initial version that was released; if the name of an existing LEA was changed, key data points will get blanked out, and that district won't work the next time they start the Data Collector (this doesn't happen if removing or adding a new submitter). This hotfix is a JAR file replacement, not an entire reinstall, so it should only take about 5 minutes. Critical point – don't change the name of any submitters until after this hotfix is installed.

### **Q&A**

**Q:** Do you know when the spreadsheet for the Science of Reading information will be shared out?

**A:** That Data Collection is on a temporary hold. Additional ODEW staff joined the conversation surrounding this topic and are still discussing whether or not this information is needed. ODEW has been told to hold on distributing this spreadsheet and collecting that data. There is no word this is going away, but they realize if this is going to move forward, that decision will need to be made in the next couple of weeks, or there won't be an opportunity to collect that data because district staff will be out for the summer. There was some language around this in both the Executive budget and House budget; we are in a little bit of a holding pattern to see what the Senate's thoughts are on collecting this type of information. The Code is written and ready to go, but ODEW was asked to hold off for now.

**Q:** Today's Newsflash reminded us that the CTE Teacher Override is due 4/30/2025, but the April 9th Newsflash indicated the deadline was 4/28/2025. Do we really have until Wednesday?

**A:** Typically, the latest message is the most accurate. 4/30/2025 is the correct date.
