

ODEW EMIS-ITC Call – 6/23/2025

End of Course Vendor Results – ODEW recently discovered that some of the vendor results, indicating that a student has an End of Course (EOC) exam to report, were not showing on the EOC missing assessment list, and the student did not have a corresponding enrollment record. Districts have reported the vast majority of those EOC assessment results. However, there are some districts that ODEW added one to five students to the missing list for the FY25 End of Course Assessment collection. It is possible that those districts might think they have submitted all of the required assessment results.

ODEW will be sending an EMIS Newsflash out later this week regarding this and will likely send a message through the Data Collector to districts that had students added to the missing list. They will also be sending ITCs a list of counts by LEA on how many students were added to the missing list. ODEW is asking ITCs to encourage districts to check their FY25 End of Course Assessment collection. The collection closes on July 16th.

Data Collector Hot Fix – Alex Katz will send notifications to ITCs of a Hot Fix for the Data Collector. This hot fix will fix a couple of issues and has one additional feature. You can install this by switching out the JAR file; it does not require a full installation.

The new feature is for ITC Staff and adds a Message Details link for each Message. The Message Details will list which users have opened the message at each district (opened up and marked as read), as well as anyone at that district who has access but has not seen the message. There will also be a new filter option to view messages that have not been opened by anyone at an LEA. This will then allow ITCs to send out communications to those districts to follow up.

Data Summary Comparison Reports – Result Code DC0092 has been added recently. A lot of districts had issues last year with their Reading Diagnostics and students showing up as Required, Not Assessed (RN), either because they did not submit data for those students, or because they submitted data with incorrect dates for the assessment that were not within the required assessment window. This has a significant impact on the Literacy Measures of the Local Report Card. It is very important that districts look at the Result Code DC0092.

For this result code, ODEW is comparing the total number of students that have a result code of RN last year (FY24) to the total number of students that have a result code of RN this year (FY25). It will then compare those two numbers and give you a percentage change (-/+). Unlike a Gen Issues, this number gets calculated for every district. Districts will want to verify this information on their FY24 and FY25 (LTRC-001) Derived Reading Diagnostic Result Report.

ODEW has also added result codes DC0090 and DC0091 that compare Preschool data. In addition, ODEW is in the process of adding result codes around finance data, Career Technical data, and missing percent around assessments.

Q: If a district has the DC0092, but on their Reading Diagnostic, they are not seeing the RN for any students. Why would they still have the DC0092?

A: There are a couple of possibilities, one being a timing issue. This Reading Diagnostic result code check is run manually and is not run every night. So, if they have recently fixed their data or submitted things that made those RNs go away, it will take a few days before the DC0092 will

update its percent and show they have everything reported. Another possibility is that we have a bug. If the district didn't submit updated data around that reporting, have that district put in a help desk ticket so we can look at the situation.

Q: How often is this report updated and published? So users can look at the report and know there's an issue to resolve.

A: Typically, about once a week. Some of them are more often than that, and like Gen Issues, they are all not necessarily on the same day. They are updated as ODEW staff manually update those.

Holiday Data Processing – ODEW will process data on Wednesday night, July 3rd. However, due to the July 4th holiday, ODEW is looking at either not processing data on Thursday night or not processing data on Saturday night. If they do not process on Saturday, any data submitted by Friday will not be processed until Monday night. If they do not process on Thursday night, those Thursday submissions will get picked up with Saturday's processing.

Q&A

Q: I have a user who is focusing on L Student Grade, and it's been processing since June 15th. Is it typical to sit out there for a number of days?

A: That collection is processed once a week. That processing happens on Saturday night or Sunday morning. If that submission missed the cutoff time for processing, it may sit there for up to a week. Everything should be fine because all of the processing finished over the weekend. But we are working to fix an issue with the Report Collector. Sometimes the Report Collector restarts while something is processing, and it doesn't always send a message to the Data Collector that it has been processed. We are trying to keep an eye on things to make sure they process and are unaware of anything that hasn't been processed, but some of the messaging to the Data Collector might not be complete. We are doing a hot fix to the Report Collector, just like the Data Collector, to resolve that issue.

Q: Any update to the STEM school FLUP-001?

A: I am working on this today. Hopefully, that will get completed today so districts can submit.
