Final Correction Opportunities will follow the close of each collection. Districts will have until Friday, August 15, 2025, to request a Final Correction Opportunity for these collections. Districts who are approved for a final correction opportunity will have until August 22, 2025, at 5 p.m. to submit corrected data.

FY25 Summer 3rd Grade Reading - ODEW uses the vendor results for this assessment; data should be available from the vendor this week and loaded to the Secure Data Center (SDC). Districts will want to review this data for accuracy. A Final Correction Opportunity will be open from Tuesday, August 12, 2025, through Friday, August 15, 2025.

Q: If you have kids pass the TGRA over the summer how does a district submit those?

A: If the student passes the reading assessment over the summer, the district doesn't actually submit them. ODEW will take the assessment file from the vendor and load them - they will be available on the SDC site for districts to review and verify.

Q: Should districts check SDC daily after a certain time to see the summer 3rd grade assessment data?

A: ODEW is supposed to get the vendor file on Thursday, so data will probably be loaded on Friday and should start showing up with weekend processing. Districts could begin to check at the start of next week. The scores will all be loaded at once, so if the scores are loaded and all is good, there is no need to continue checking.

New EMIS Coordinator Trainings - In person training will be held next week and does require registration. The online training sessions also begin next week and are open to anyone who would like to participate.

Q & A

Q: What will happen if a district does not submit a collection that is closing at least once?

A: The first thing that is going to happen - anything report card or otherwise that is based on that data will either not show anything or will not show information that is correct. The consequence primarily is going to be in the data reports that ODEW does. If there is a district that flat out refuses to submit a collection, the Office of Data Quality will likely be doing some follow-up on that. It very rarely happens, so hopefully districts can get data submitted or file a Correction Opportunity and complete submissions during that time.
