FY25 Funding Final Correction Opportunity – As a reminder, this correction opportunity is a chance to point out to ODEW where another district's data is impacting your funding. This correction opportunity is not an opportunity to correct your own data, but a chance to ask ODEW to correct your funding based upon what another district reported incorrectly, which caused your funding to be lower.

FY26 Economically Disadvantaged (DPIA) Funding – Over 600 entities have submitted their Student Cross Reference (SCR) Collection, which is a significant increase from this point in FY25. Several districts have submitted their SCR over 15 times. The Direct Certification matching is being run daily, so please encourage your districts to submit their SCR even if they don't have everything in order yet.

ODEW is working on calculating the CNDC DPIA FTE that will be used for the DPIA funding this year. ODEW will have business rules to show exactly how they are calculating this out, hopefully soon, so that they can share through trainings, and David will be discussing this at OEDSA. ODEW plans to make that data available for the October payments. That may not be possible for the October #1 payment for traditional districts. It may not be until after the October #2 payment, but they will make it available as soon as they can.

Q: David, you mentioned updating payments for FY26 October #1 or #2. Are you just talking about the DPIA, or are you talking about multiple things?

A: Typically, when there are changes in law, they try to get all of those changes in law into the payments starting in October. This is due to the changes in law becoming effective at the end of September. I am sure there will be other changes within the payments themselves that will come into play in October. Off the top of my head, I don't know if we are introducing any of the FY26 EMIS data into the October payments. If we are, it would probably only be for community schools since their collection opened a little bit earlier. There is a data payment calendar on our website that states when data starts to be included in FY26 payments.

This one is a little different because it is a totally new number. So, we need to include something in there; otherwise, we can't calculate the payment required by law. We may begin with FY25

data, aiming to replicate the FY26 data for comparison purposes, or we may start with FY26 data for the October payments (or November at the latest).
