Ohio School Report Card – Report Cards are now live. You can look at the data within the SDC as well.

Q: Last year, you started releasing the CCWMR Received File around mid to late September. Is that the intent again this year?

A: Yes, that is the plan. Typically, we do not release it before the report card is released, as the CCWMR report being released is about the 2025 cohort, which is not the cohort listed on the report card, and it would cause some confusion.

FY26 Collection Request – There are four collections scheduled to open on September 18, 2025.

- Summer and Fall End of Course Assessment Collection (FY26) (2026AGEFL)
- Kindergarten Readiness Assessment Collection (FY26) (2026AGOF)
- Current Graduation Credit Progress Collection (FY26) (2026SGRCR)
- Student Course Grade Collection (FY26) (2026LCGRD)

The Summer and Fall EOC and KRA collections are the first assessment collections that include support for CSV files. The CSV file support will be added to the rest of the assessment collections as they open throughout the school year. ODEW is also working on including support for CSV files for other record types, with the goal of completing this by the end of the school year.

ODEW will begin calculating the Early Warning System data this coming weekend for FY26, using the Current Graduation Credit Progress and Student Course Grade collections. It will be a little bit before they start the Progress Towards Grad for FY26. ODEW is still processing Progress Towards Graduation while the FY25 Graduation Collection is still open.

EMIS Change Call – The October EMIS Change Call has been cancelled. There was enough content to justify having a meeting. There will be some changes published this week that are coming out of the budget bill. ODEW will be talking about all EMIS Changes (before and after the budget) at OEDSA at the end of the week.

Reminding FY25 Collections – The Graduation Collection is currently open until October 10, 2025. The Final Correction Opportunity for that will be open from October 13 – 24, 2025.

The Financial Final Correction Opportunity is currently open and will close on September 19, 2025. The deadline to submit corrected data in EMIS for approved final correction opportunities is October 3, 2025, at 5:00 p.m.

The CTE Program of Concentration Final Correction Opportunity is currently open and will close on September 26, 2025. Now that all of the data is finalized, ODEW has the Program of Concentration they will use for the Exiting Student Follow Up, which is scheduled to open on October 16, 2025. Districts need to review the final Program of Concentration that ODEW has calculated for students.
