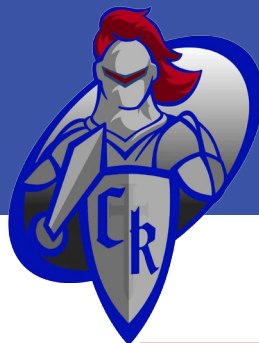

### ABOUT THE DISTRICT

Crestview Local Schools is a district located on the western side of rural Van Wert County, Ohio. Its small size and strong community involvement are its core features while it serves as the heart of the community and boasts a strong tradition of student-centered academics.

Crestview is comprised of four schools over two adjacent campuses. In addition to the buildings, the campus also includes an athletic complex which is home to many sports teams.

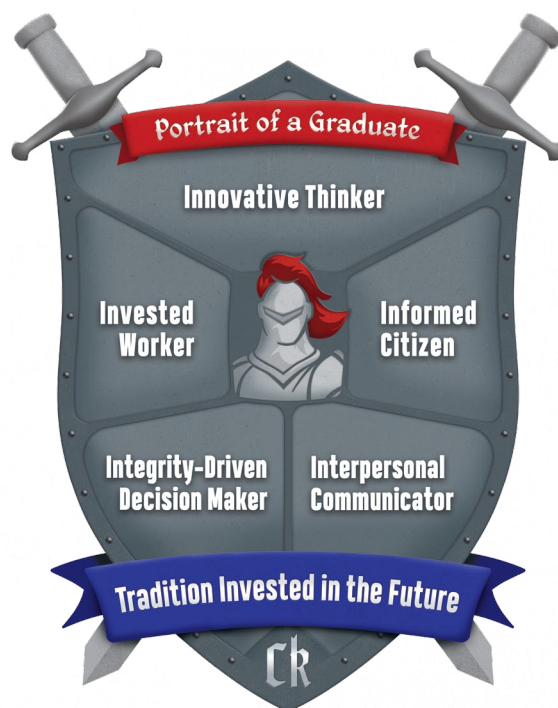
