The Community

The Milton-Union (M-U) Exempted Village School District is comprised of Union Township in rural Miami County. Its 48 square miles contain the village of West Milton, population 4,700, and three smaller towns, Ludlow Falls, Potsdam and Laura. M-U is the largest employer in the township.

The village of West Milton is easily accessible, 15 miles north of Dayton and 7 miles from the Dayton International Airport. Nestled along the Stillwater River, it is 4 miles from the I-70 and I-75 intersect. Three state routes transverse the village.

Within commuting distance are numerous public and private two-year and four-year colleges and universities, including the University of Dayton, Wright State University, Edison Community College, Sinclair Community College, Urbana College and Cedarville University.

The School District

Milton-Union has approximately 1,422 students. While the district has experienced a gradual decline in enrollment, the percentage of students on openenrollment continues to climb, currently making up over 10% of the student body.

M-U offers all day, every day kindergarten, an on-site preschool and Head Start for children 3-5 years of age. Students enjoy many opportunities, academically, athletically and in the fine arts. Middle and high school students participate in a blended education through partnerships with Montgomery County Career Technology Center (both on-site and off) and College Credit Plus classes.

The PK-12 facility itself sits on 130 acres of former farm land and is comprised of 44 acres of woods; 11 acres dedicated to open prairie, 45 acres of sports fields and 4 acres consist of playgrounds, landscaped areas and rain gardens. The facility, dedicated in 2012, is LEED Gold, Energy Star rated and was one of nine districts in the country recognized in 2014 as a Green Ribbon school by the U.S. Department of Education.
