The Search

The Elida Local School District, located in Allen County, is seeking qualified applicants for the position of CFO/Treasurer. The expected start date will be May 1, 2024, or sooner.

About the Elida Local Schools

Elida Local Schools is located in Allen County and serves the Village of Elida, Gomer and a portion of the city of Lima covering 68 square miles.

The district has approximately 284 employees serving roughly 2,200 students. With two state-of-the-art buildings – the high school opened in 2011 and the elementary opened in 2021 – the district has some of the best facilities in Northwest Ohio, hosting dozens of athletic tournament events throughout the year. Academically, the district provides several College Credit Plus offerings, some Advanced Placement (AP) courses, has a tremendous fine arts program and much more. The district has also been recognized for having all three buildings named as Purple Star buildings – indicating a strong commitment to meet the needs of military families.

The treasurer's office includes two assistants... a payroll and benefits specialist, and an accounts payable/receivable specialist.

Qualifications

The successful candidate must possess a master's degree with valid Ohio School Treasurers license, or evidence that one is obtainable, must be visible and accessible to staff and community members, and forges a positive, respectful, and trusting partnership with the Board of Education.
